**ORDINANCE No. 28  
OF THE RECTOR OF THE UNIVERSITY OF WARSAW**

dated 28 February 2022

**on the establishment of the Crisis Staff for Ukraine  
at the University of Warsaw**

Pursuant to the provisions of paragraph 36, section 2, point 12 of the Statute of the University of Warsaw (Monitor UW of 2019, item 190), it is hereby ordered as follows:

§ 1

In connection with the attack of the Russian Federation on Ukraine, the Crisis Staff for Ukraine at the University of Warsaw (hereinafter referred to as the "Crisis Staff") is established composed as follows:

The tasks of the Crisis Staff are:

- 1) organising and coordinating research, teaching, scientific and welfare assistance for the employees, doctoral students and students from Ukraine;
- 2) monitoring and preventing the danger to the University resulting from the armed conflict in Ukraine;
- 3) undertaking the necessary intervention measures;
- 4) gathering and updating all news and data on the assistance initiatives for Ukraine;
- 5) maintaining cooperation and communication with the external environment;
- 6) coordinating the activities of subordinate staff in organising aid actions at the University;
- 7) undertaking other tasks commissioned by the Rector.

## § 3

The ordinance enters into force on the day it is signed.
