**ORDINANCE No. 114
OF THE RECTOR OF THE UNIVERSITY OF WARSAW**

of 20 September 2022

**on amending Ordinance No. 142 of the Rector of the University
of Warsaw of 1 October 2019 on the introduction of the Rules and
Regulations of Students' Benefits at the University of Warsaw**

Pursuant to Article 95, section 2 of the Act of 20 July 2018 – the Law on Higher Education and Science (consolidated text: Journals of Law of 2022, item 574, as amended), it is hereby ordered as follows:

§ 1

The Rules and Regulations on Students' Benefits at the University of Warsaw, annexed to Ordinance No. 142 of the Rector of the University of Warsaw of 1 October 2019 on the introduction of the Rules and Regulations on Students' Benefits at the University of Warsaw (consolidated text: UW Monitor of 2021, item 186, as amended), hereinafter referred to as the "Rules and Regulations", are hereby amended as follows:

1) in § 17, section 2:

a) point 3 shall read:

"3) the applicant is dependent on parents, legal guardians or actual guardians regularly and currently receiving one or more of the following benefits: permanent allowance, purpose-specific allowance, periodic allowance, special purpose-specific allowance, attendance allowance or childcare benefit, or is himself/herself regularly and currently receiving them;"

b) following point 5, points 6 and 7 shall be inserted and read as follows:

"6) the student's daily commute from their permanent place of residence makes it difficult or impossible for them to study;

7) the student has been awarded the Rector's scholarship or the Minister's scholarship for significant achievements in the academic year, preceding the one in which the student applies for a social scholarship.";

2) in § 24:

a) section 4 shall read:

“4. The Rector's scholarship shall not be granted if the application is submitted after the deadline set by the Rector. The application submitted after the deadline shall be left without consideration.”

b) section 10 shall read:

“10. The Rector's scholarship may be also granted to a first-year student of the second-cycle studies who:

1) has obtained outstanding learning outcomes in the last year of the first-cycle studies, or

2) in the cycle of studies preceding the one for which the scholarship is applied for, and has obtained:

a) scientific achievements, or

b) artistic achievements, or

c) sports achievements in at least national competitions

- provided that they began their second-cycle studies for which the rector's scholarship is applied for within 12 months from the date of completion of the first-degree studies.”;

3) in Appendix No. 1 to the Rules and Regulations in § 8, section 6 shall read as follows:

The contract referred to in section 5, point 1 shall be considered to be a lease agreement concluded in writing for a period of at least 10 years and reported to the land and building register by a person receiving farmer's disability pension with a person, who is not:

1) the disability pensioner's spouse;

2) the person living with the disability pensioner in the same household;

3) the spouse of the person referred to in point 2.”;

4) in Appendix No. 3 to the Rules and Regulations:

a) in § 5:

– section 3 shall read:

“3. In case the student has completed a given stage of studies while being a student of another higher education institution, the average grade calculated in accordance with the principles laid down in the rules and regulations of studies of that institution shall be taken into account, with rounding off to hundredths.”,

– section 7 shall read:

“7. The average grade obtained by the student on a scale other than 2.0 - 5.0 shall be replaced by the equivalent, rounded to hundredths, converted according to the following formula.

$$\text{average_grade} = (A - G_1) / (G_2 - G_1) * 3 + 2$$

A – average grade from another
higher education institution

G₁ - the lowest grade on the scale

G₂ - the highest grade on the scale.”

b) § 10, section 2 shall be repealed.

§ 2

The ordinance enters into force on the day it is signed.
