**ORDINANCE No. 141
OF THE RECTOR OF THE UNIVERSITY OF WARSAW**

of 25 August 2025

**on amending Ordinance No. 100 of the Rector of the University of Warsaw
of 30 May 2025 on the fees for educational services
for foreign students undertaking studies
in the academic year of 2025/2026**

Pursuant to Article 79, section 1, points 1-4 of the Act of 20 July 2018, the Law on Higher Education and Science (consolidated text: Journal of Laws of 2024, item 1571, as amended) and § 3, section 1, in conjunction with § 2, sections 1 - 4 of Ordinance No. 130 of the Rector of the University of Warsaw of 30 September 2019 on the rules and regulations for charging, and on conditions and procedure for exemption from the fees for educational services at the University of Warsaw (consolidated text: UW Monitor of 2021, item 214), it is hereby ordered as follows:

§ 1

Ordinance No. 100 of the Rector of the University of Warsaw of 30 May 2025 on the fees for educational services for foreign students undertaking studies in the academic year of 2025/2026 (UW Monitor of 2025, item 225) shall be amended as follows:

- 1) the title of the Ordinance shall read as follows: "on the fees for educational services for foreign students commencing education at full-time studies in Polish in the academic year of 2025/2026";
- 2) in the legal basis, the words "Article 79, section 1, points 1-4" shall be replaced by the following "Article 79, section 1, points 1-5".

§ 2

The appendix to Ordinance No. 100 of the Rector of the University of Warsaw of 30 May 2025 on the fees for educational services for foreign students undertaking studies in the academic year of 2025/2026, shall be amended as follows:

- 1) in point 36, the words "New-Greek philology" shall be replaced by: "New-Greek studies";
- 2) in point 45, the field of studies: business finance and accounting, the title of fee - type of educational service, the words: "Full-time evening studies" shall be replaced by "Full-time studies";

3) point 63 shall have the following wording:

"63. field of studies: computer science
